An applicant must submit this permit application to Village Hall with the signed affidavit and acknowledgement, a copy of his/her driver's license, proof of insurance and \$150 fee. The \$150 fee is payable at Village Hall and may be paid by check, cash or credit/debit card. Please note a processing fee will be charged if a credit/debit card is used. Registration expires on April 30th of every year and must be renewed annually.

Affidavit and Acknowledgement

I, the undersigned applicant, or authorized agent thereof, swear or affirm under penalties of perjury that the matters stated in the forgoing permit application are true and correct, are made upon my personal knowledge and information, and are made for the purpose of requesting the Village of Hampshire to issue the permit herein applied for. I further swear or affirm that I have not omitted any information that is required, that the matters stated herein are not misleading in light of the purposes for which this permit application is made, and that the applicant is qualified and eligible to obtain the permit applied for.

I further swear or affirm that the applicant will not violate any applicable laws, rules, ordinances or regulations relating to or regulating golf carts or electric UTVs in the Village of Hampshire or the State of Illinois. I understand and acknowledge that all persons who operate or ride golf carts or electric UTVs on Village of Hampshire streets do so at their own risk.

Permitted Streets: Operation of golf carts and electric UTVs shall be permitted on the streets within the Village of Hampshire that have a posted speed limit of thirty-five (35) miles per hour or less.

Vehicle Equipment: I verify that the golf cart or electric UTV has all equipment required by the Illinois Vehicle Code (625 ILCS 5/1-100, *et seq.*) and the Municipal Code of Hampshire of 1985 (the "Village Code") and that all equipment is operational and in good working condition.

Insurance: Any person who operates a golf cart or electric UTV in the Village of Hampshire shall be subject to the mandatory insurance requirements set forth in Article VI of Chapter 7 of the Illinois Vehicle Code (625 ILCS 5/7-601, *et seq.*)

Failure to comply with the applicable requirements set forth in Article VIII of Chapter 2 of the Village Code may result in a penalty, including a fine, suspension, revocation, failure to issue or failure to renew a permit.
